\*Please note the previously used index for Energy, Table 3.3.2 (Fuel price indices for the industrial sector) is no longer included within the <u>Quarterly Energy Prices</u> publication and therefore it has been replaced by Table 3.1.1 (Average prices of fuels purchased by the manufacturing industry). This replacement took place in Textile Services Cost Index: 2021/2022 FYQ4.

\*\*Please note, the NICs Secondary Threshold decrease that came into effect from 6<sup>th</sup> April 2025 creates an additional 1.25% increase to labour cost for the Laundry Industry. However, to ensure that the Textile Services Cost Index (TSCI) remains linked to official government indices, the TSCI only incorporates the change in the secondary Class 1 NICs rate from 13.8% to 15%. It disregards the real cost increase resulting from the reduction in the threshold (the earnings after which an employer becomes liable to pay secondary Class 1 NICs on a given employment). The TSA has surveyed its members and found that the impact on the laundry industry of the threshold changes is an approximate additional increase in labour cost of 1.25% and would result in the TSCI of 3.05%.
