





TRAINING MODULES - RATIONALE:

This guidance represents the **expected standard of best practice** for the safe management of laundry within care homes. All care providers should work towards meeting these standards in full to ensure effective infection prevention and control and the protection of residents, staff, and visitors.

Where a care home is **unable to meet the standards** due to building design, resource, or operational constraints, **a risk assessment must be undertaken in consultation with the organisation's Infection Prevention and Control (IPC) lead.** This assessment should identify safe and practical ways to mitigate any risks.

If the care home cannot safely manage laundry services on-site, these services should be **outsourced to a suitably accredited external laundry provider.** The provider must operate in compliance with **HTM 01-04: Decontamination of linen for health and social care**, and, where appropriate, be accredited to **BS EN 14065:2016 – Textiles: Laundry processed textiles – Biocontamination control system.**

DEFINITIONS:

- Linen: All reusable textile items requiring washing / disinfection via laundering processes.
- Clean linen: Linen that has been laundered (washed / disinfected / ironed) and is ready to be re-used.
- Used linen: Linen that has been used and is not visibly contaminated by blood, urine, faeces or vomit and there is no known or suspected infection.
- Infectious linen: Linen that has been used by a resident known or suspected to be infectious, and/or, linen that is contaminated (fouled) by blood, urine, faeces, or vomit. N.B. cleaning cloths and mops must be laundered as 'infectious' linen and separately from any other linen.
- Laundry: Environment where linen is laundered.
- Laundering: The process of washing, disinfecting, drying and ironing linen rendering it suitable to be re-used.
